

## **ORDINANCE NO. 3 SERIES OF 2024**

### **AN ORDINANCE OF THE TOWN OF WILLIAMSBURG, COLORADO, RE-ADOPTING THE CURRENT CODE BOOK**

**WHEREAS**, the Town of Williamsburg, Colorado recognizes the necessity of maintaining an updated and comprehensive set of codes and regulations for the governance and well-being of its residents; and

**WHEREAS**, the Town has reviewed and revised its current code book to ensure it reflects contemporary standards, regulations, and best practices; and

**WHEREAS**, the Board of Trustees of Williamsburg, Colorado, deems it in the best interest of the Town and its residents to formally re-adopt the revised code book as the official set of ordinances and regulations;

**NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF WILLIAMSBURG**

#### **Section 1: Re-Adoption of the Town of Williamsburg Code**

The code entitled "Williamsburg Municipal Code," published on the Town of Williamsburg official website and one (1) physical copy on file in the office of the Town Clerk, consisting of Chapters 1 through 18, with tables and index, constitutes a compilation, revision, and codification of all the ordinances of the Town of Williamsburg, Colorado, is hereby formally re-adopted as a primary code by reference. Nothing herein shall be interpreted as a suggestion that the Williamsburg Municipal Code originally adopted in 2004, and as subsequently amended from time to time, has not previously been the Code for the Town of Williamsburg during that time period.

#### **Section 2: Repeal of Inconsistent Ordinances**

All ordinances or portions of ordinances of a general and permanent nature enacted on or before September 17, 2024, which are inconsistent with the provisions of the Town of Williamsburg Municipal Code, to the extent of such inconsistency and not otherwise saved from repeal, are hereby repealed.

#### **Section 3: Title Page Addition**

A title page shall be added to the Code Book to read as follows: Town of Williamsburg, Colorado established 1888, Municipal Code current through: Ordinance 3 Series of 2024, passed [insert date], 2024. 1 John Street, Williamsburg, CO 81226

#### **Section 4: Amendment to Section 1-2**

“Sec. 1-2 Title and Scope” shall be amended to read as follows:

### **Section 1-2: Designation, Citation of Code**

The ordinances embraced in this and the following chapters shall constitute and be designated as the "Williamsburg Municipal Code," and may be so cited.

**State law reference**—Ordinance codes adopted by reference, C.R.S. 1973, 31-16-201 et seq.

### **HISTORY**

Adopted by Ordinance 1 Series of 2024 on Sept 17, 2024.

### **Section 5: Footer Designation and Page Numbering**

The designation “Williamsburg Municipal Code” and page numbering will be added into the footer of the Code pages. Page numbering will designate the chapter and page number out of the total pages within that chapter, such as Chapter 1, Page 1 of 5.

### **Section 6: Citation of Ordinances**

The Code shall remove the insertion ordinance documents into Code Sections but will rather cite the applicable amending ordinance in parentheses. An “Ordinance List and Disposition Table” shall be created, listing and describing ordinances and resolutions and will be attached at the end of the Code. If an ordinance amends the Municipal Code, it will cite the applicable Code Section in the “Ordinance List and Disposition Table”.

### **Section 7: Amendment to Section 1-47**

“Sec. 1-47. Publication of Ordinances” shall be amended as follows:

All ordinances, as soon as may be after their passage, shall be recorded in a book kept for that purpose and authenticated by the signature of the Mayor and Town Clerk. The ordinances shall take effect upon their final passage, adoption, and the approval and signature of the Mayor if they are adopted by an affirmative vote of a quorum of the members of the Board of Trustees and shall be posted on three (3) designated locations for Public Notifications in accordance with CRS31-16-105. ([Ordinance 5 of 2010, which is reaffirmed with the passage of this ordinance](#))

### **Section 8: Fees and Fines Table**

All fees and fine tables located within the Code shall be placed in an administrative “Fees and Fines Table” attached at the end of the Municipal Code and enacted by ~~Resolution~~ Ordinance.

### **Section 9: No Revival of Previously Repealed Ordinances**

The repeal established herein shall not be construed to revive any ordinance or part thereof that had been previously repealed by any ordinance which is further repealed by this Ordinance.

### **Section 10. Severability**

If any section, subsection, sentence, clause, or phrase of this ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of this ordinance.

### **Section 11. Effective Date**

This ordinance shall take effect upon the date of adoption.
