ORDINANCE NO. 1 SERIES OF 2025

INTRODUCTION AND FIRST READING, ORDINANCE NO. 1 SERIES OF 2025: AN ORDINANCE FOR SETTING THE WATER RATE SCHEDULE FOR 2025.

WHEREAS, residents are interested in paying only for water they use; and

WHEREAS, the residents of the Town of Williamsburg, through their water bills, must pay for Williamsburg water system debt retirement, their portion of Florence's water treatment plant debt retirement, Florence cost compensation, the costs of administering the Town of Williamsburg water system, and saving funds towards Systems Development for major system repairs and upgrades; and

WHEREAS, these charges are allocated equally and evenly to all water taps on the water system; and

WHEREAS, the amounts billed to residents for water used must be sufficient to pay for the water treatment and transportation at the volume billed to the Town of Williamsburg by the Town of Florence;

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF WILLIAMSBURG, TO SET WATER RATES AND FEES AS FOLLOWS:

- 1. Water at \$.60 per 100 gallons
- 2. Florence water treatment plant debt relief at \$20.26
- 3. Williamsburg capital improvements debt relief at \$9.62
- 4. Administrative services at \$19.00
- 5. System Development Fund at \$1.00
- 6. Florence cost compensation at \$5.38

This ordinance shall take effect upon the date of adoption.

RESOLUTION NO. 4 SERIES OF 2025

A RESOLUTION OF THE BOARD OF TRUSTEES OF THE TOWN OF WILLIAMSBURG, COLORADO, AUTHORIZING THE TOWN OF WILLIAMSBURG TO JOIN WITH OTHER LOCAL GOVERNMENTS AS A PARTICIPANT IN THE COLORADO LOCAL GOVERNMENT LIQUID ASSET TRUST (THE TRUST).

WHEREAS, pursuant to Part 7, Article 24 of the Colorado Revised Statutes (C.R.S.), it is lawful for any local government to pool any moneys in its treasury that are not immediately required to be disbursed with the same such moneys in the treasury of any other local government in order to take advantage of short-term investments and maximize net interest earnings; and

WHEREAS, the Trust is a statutory trust formed under the laws of the state of Colorado in accordance with the provisions of Parts 6 and 7, Article 24 and Articles 10.5 and 47 of Title 11 of the Colorado Revised Statutes regarding the investing, pooling for investment, and protection of public funds; and

WHEREAS, the Board of Trustees for the Town of Williamsburg desires to join with other local governments as a Participant in the Trust to pool funds for investment and maximize net interest earnings.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF WILLIAMSBURG, COLORADO, AS FOLLOWS:

Section 1. Authorization to Participate in the Trust The Town of Williamsburg hereby approves, adopts, and joins as a Participant with other local governments pursuant to Part 7, Article 75, Title 24 of the Colorado Revised Statutes in that certain Amended and Restated Indenture of Trust entitled the Colorado Local Government Liquid Asset Trust (COLOTRUST), dated May 1, 2021, as amended from time to time, the terms of which are incorporated herein by this reference. A copy of the Indenture of Trust shall be filed with the minutes of the meeting at which this Resolution was adopted.

Section 2. Designee and Authorized Signatories The Designee and Authorized Signatories for the Town of Williamsburg are those persons listed on the Trust Registration Form attached hereto and incorporated herein. The Authorized Signatories are authorized by the Town to direct the investment of the Town's funds in accordance with the terms of the Trust.

Section 3. Modification of Designee and Authorized Signatories The Designee and Authorized Signatories may be changed from time to time by written notice to COLOTRUST.

Section 4. Investment Portfolios The Trust currently offers three investment portfolios: COLOTRUST PRIME, COLOTRUST PLUS+, and COLOTRUST EDGE. Prior to investing in any of the portfolios offered by the Trust, the Town of Williamsburg is encouraged to review the COLOTRUST Information Statements and Investment Policies for each portfolio.

TOWN OF WILLIAMSBURG RESOLUTION FOR EXEMPTION FROM AUDIT

(Pursuant to Section 20-1-604, C.R.S.)

RESOLUTION NO. 6 SERIES OF 2025

A RESOLUTION FOR EXEMPTION FROM AUDIT FOR FISCAL YEAR 2024 FOR THE TOWN OF WILLIAMSBURG, STATE OF COLORADO.

WHEREAS, The Board of Trustees of the Town of Williamsburg wishes to claim exemption from the Audit Requirements of Section 29-1-603, C.R.S. and

WHEREAS, Section 29-1-604, C.R.S. states that any local government where neither revenues nor expenditures exceed seven hundred fifty thousand dollars may, with the approval of the state auditor, be exempt from the provision of Section 29-1-603, C.R.S. and

WHEREAS, neither revenues nor expenditures for The Town of Williamsburg exceed \$750,000 for fiscal year 2024; and

WHEREAS, an application for exemption from audit for The Town of Williamsburg has been prepared by **Prospective Business Solutions, LLC, Certified Public Accountants**, an independent accountant with knowledge of governmental accounting; and

WHEREAS, said application for exemption from audit has been completed in accordance with regulations issued by the State Auditor.

NOW THEREFORE, be it resolved by the Board of Trustees of the Town of Williamsburg that the application for exemption from audit for The Town of Williamsburg for the fiscal year ended December 31, 2024, has been personally reviewed and is hereby approved by a majority of the Board of Trustees of the Town of Williamsburg that those members of the Board of Trustees have signified their approval by signing below; and that this resolution shall be attached to, and shall become a part of the application for exemption from audit of the Town of Williamsburg for the fiscal year ended December 31, 2024.
