RESOLUTION NO. 4 SERIES OF 2024

**A RESOLUTION OF THE TOWN OF WILLIAMSBURG, COLORADO CANCELING THE 2024
MUNICIPAL ELECTION AND DECLARING THE CANDIDATES ELECTED**

WHEREAS, Colorado Revised Statutes § 31-10-306 state that write-in candidate affidavits must be filed no later than sixty-four (64) days before the election date; and

WHEREAS, the Town of Williamsburg adopted Ordinance No. 4, Series 2024, which requires an affidavit of intent for write-in candidates as provided in Colorado Revised Statutes § 31-10-306;

WHEREAS, Colorado Revised Statutes § 31-10-307 States the governing body may also provide that, if the only matter before the voters is the election of persons to office and if, at the close of business on the sixty-fourth day before the election, there are not more candidates than offices to be filled at such election, including candidates filing affidavits of intent, the clerk, if instructed by resolution of the governing body either before or after such date, shall cancel the election and by resolution declare the candidates elected;

WHEREAS, If so provided by ordinance, upon such declaration the candidates shall be deemed elected. Notice of such cancellation shall be published, if possible, in order to inform the electors of the municipality, and notice of such cancellation shall be posted at each polling place and in not less than one other public place;

WHEREAS, the only matter before the voters at the 2024 Regular Municipal Election is the election of persons to office; and

WHEREAS, at the close of business on the 64th day prior to the 2024 Regular Municipal Election there were not more candidates than offices to be filled at such election, including candidates filing affidavits of intent as write-in candidates;

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF WILLIAMSBURG, COLORADO, THAT:

1. The Regular Municipal Election scheduled for Tuesday, November 5, 2024 is hereby canceled
2. All candidates are hereby declared elected and shall take office November 12, 2024.

WHEREAS, the Revised Statutes § 31-10-301 State: the governing body may also provide the voters in the election of persons to office and if, at the close of the day before the election, there are not more candidates than officers to be elected, the governing body either before or after such date, shall cancel the election and substitute officers;

WHEREAS, as provided by ordinance, upon each declaration the candidates shall be declared elected. Notice of such declaration shall be published, if possible, in order to inform the citizens of the municipality, and notice of such declaration shall be posted at each polling place and in not less than one other public place;

WHEREAS, the only notice before the voters of the 2024 Regular Municipal Election is the election of persons to office; and

WHEREAS, at the close of business on the 14th day prior to the 2024 Regular Municipal Election there were not more candidates than officers to be elected of which election, including candidates filing affidavits of intent to serve as candidates;

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF WILLIAMSBURG, COLORADO, THAT

1. The Regular Municipal Election scheduled for Tuesday, November 5, 2024 is hereby cancelled.
2. All candidates are hereby declared elected and shall take office November 12, 2024.
