**ORDINANCE SUBMITTING PROPOSED REMOVAL OF REVENUE AND SPENDING  
LIMITS TO THE PEOPLE OF THE TOWN OF WILLIAMSBURG AND SETTING A  
BALLOT TITLE THEREFORE**

BE IT ORDAINED and enacted by the Board of Trustees of the Town of WILLIAMSBURG, Colorado, a statutory municipality, the following:

471412616. Pursuant to C.R.S. § 31-10-109 and 31-11-111 (2), the Board of Trustees hereby submits to the registered electors of the Town of WILLIAMSBURG the question of whether revenue and spending limits imposed by Article X, Section 20 of the Colorado Constitution and the 5.5% property tax limitation of C.R.S. § 29-1-301 shall be lifted beginning in levy year 2021.

471412617. The Board of Trustees hereby fixes the following ballot title for this referred measure as follows:

ENDING LIMITSREMOVAL OF REVENUE AND SPE.

471412618. The Board of Trustees hereby sets the ballot Submission Clause to read as follows:

WITHOUT RAISING TAXES, SHALL THE TOWN OF WILLIAMSBURG BE AUTHORIZED TO COLLECT, RETAIN, AND EXPEND THE FULL PROCEEDS GENERATED BY ANY REVENUE SOURCE OF THE TOWN, BEGINNING IN LEVY YEAR 2022 AND CONTINUING, AS A VOTER- APPROVED EXCEPTION TO THE REVENUE AND SPENDING LIMITS OF ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION. THE 3.49% PROPERTY TAX LIMITATION OF SECTION 29-1-301, COLORADO REVISED STATUTES, AND ANY OTHER LAW; PROVIDED THAT THE TOWN'S PROPERTY TAX RATE SHALL NOT BE INCREASED WITHOUT THE VOTERS' PRIOR APPROVAL?
